



Gatherings

Is there a curfew?

No, we do not have a curfew in place.

Are social gatherings permitted?

Except for households of more than 10 persons, gatherings of more than 10 people (public or private) are not allowed inside or outside. While churches can still have services, according to the ordinance no more than 10 people could be present. Virtual services are strongly encouraged.

Business

What Businesses are required to close? Gyms, fitness centers, indoor amusement facilities, bowling alleys, pool halls, movie theater, massage parlors, nail salons, hair salons, barber shops and tattoo parlors and other businesses similar to these businesses.

Are all businesses required to close? No. Only the businesses referenced above. Businesses are required to post signage on the door requiring 6 feet of separation.

Are industries or manufacturing facilities required to close? No. However, they are also required to implement social distancing of 6 feet by order of Georgia Governor Brian Kemp.

I am a business allowed to remain open, what are my requirements?

Businesses are required to post social distancing protocols (flyers) and enhance sanitation measures.

Restaurants

Can restaurants be open?

Restaurants can be open for drive-through, pick up or delivery. No dine-in services are permitted. While working, employees must maintain social distancing protocols and sanitation measures.

Can people wait for their pick up order inside?

No, you can offer curbside or drive-through.

Can restaurants sell alcohol to-go?

Properly licensed restaurants are allowed to sell unopened containers of beer and wine for take-out consumption off-premises.

Outside Activities**Can I use The Thread?**

The Thread is open to bike, walk or run but you must maintain social distancing from others.

Can I use the Granger or Chris Joseph Track?

The track is open for walking or running but no organized sporting events. Social distance must be maintained.

Are Parks and Playgrounds open?

All parks, their facilities and amenities are closed to the public.

Can I walk on the sidewalks in my neighborhood?

Yes, as long as you maintain social distancing from others.

City-Related Questions**Are City Hall and other City Departments open to the public?**

Our facilities are closed to the public until further notice. Utility customers may still make payments through the drive-through, online or by phone. License payments can be mailed to 200 Ridley Avenue, LaGrange, GA 30240. Building permit inquiries need to be directed to Community Development Director Alton West at 706-883-2060.

Will garbage pick-up continue?

Garbage, Trash (limb and leaf/bulky items) and Recycling pick-up will continue on its normal schedule.

Are City events, programs, classes, etc. canceled or postponed?

All upcoming city-sponsored events, events to be held in city-owned facilities, programs, classes, etc., are canceled or postponed until further notice.

Will my utilities be disconnected during the emergency for non-payment if I get into a financial trouble? No, however customers should be aware that this will not forgive the debt. The City will work out payment arrangements to address any past due amounts.
